MINUTES OF THE ALREWAS PARISH COUNCIL MEETING MONDAY 18 JULY 2022 HELD AT THE VILLAGE HALL AT 7.30PM

1 Apologies

a **RESOLVED:** To approve apologies for absence: Mrs Adams – holiday booked before she became a Cllr, Cllr Jessica Nicklin - holiday, Cllr Elizabeth Lawler – family commitment, District Cllr Derick Cross – holiday, CCllr Janet England – precautions due to National Red Alert heat warning, PCSO Tracy Horton – another meeting.

b Noted: that the meeting was quorate

2 Police liaison

a Noted: that the PCSO was unable to attend to make a report due to another meeting.

4 Minutes

a **RESOLVED:** to approve without amendment, the Minutes of the meeting held on 20 June 2022 (APC/22-23/2/M) **ACTION: Clerk**

b Members of the public: Noted: that no members of the public had asked to speak.

c District Cllrs: Noted: that LDC Cllrs and Officers were preparing for the 2023 elections. Cllrs had rejected an increase in their allowance recommended by an external body as it was felt inappropriate at a time of national cost pressures. A Youth Parliament/Assembly was being developed to give a route to obtaining views from younger members of the community and to create useful skills for participants.

d County Cllr

Noted: that the CCllr had circulated information to the Parish Clerk for distribution to Cllrs. SCC had been given extra funding by central government but much had been taken up in cost rises. A new Board for leaders of local authorities within the County had been set up to increase co-ordination and improve services. Highways work was being taken in house and local companies would be asked to tender for work. The Parish Council asked about service standards to ensure that work would be of an appropriate standard. This was being considered by SCC as part of the process.

8 Closure of Alrewas Post Office

a Considered: A verbal report from Cllr Reilly on the forthcoming closure of the Post Office. An advertisement for the Post Office franchise in Alrewas had been issued by the Post Office. It had been stated that only retail premises could be considered as a location. Agreed: a letter would be sent to the Post Office asking about future plans and any further options open to the village, including a possible mobile post office facility, stressing that the Post Office was a valuable local resource. Local businesses would be contacted to see if they would take on the franchise.

d Quarry working group

Reported: Cllr Threlfall had attended a meeting with KBPC and HS2. Considerable disruption would happen locally shortly with the closure of the Streethay A38 junction southbound for 15 months and train disruption between Burton and Lichfield and on the West Coast main line.

Wood End Lane would be redeveloped to take more heavy traffic and may become an A road. Cemex was preparing to start work at the Orgreave site. Cllr Threlfall had met with members of SCC to try and arrange that they would provide earlier notification of future planning application for quarrying.

f Traffic Management working group

Reported: A helpful meeting had been held with a Cllr from Hammerwich to discuss speed devices and a proposal may be made to the Parish Council once the results of the data survey were provided by SCC. A proposal to develop an information leaflet about damage to sandstone kerbstones by pavement parking might be brought to a future meeting. A few noisy vehicles were being a nuisance and Cllr Hupperdine would discuss issues with the PCSO. Consideration was being given to placing planters near the school to limit dangerous parking. A proposal would be made to a future meeting. Notes of the previous meeting had been circulated to Cllrs.
